The corridor connection will provide a high capacity transit line through the highly congested Sepulveda Pass to connect the San Fernando Valley to the Westside of Los Angeles. The transit connector will build on the high-occupancy vehicle lanes that are currently under construction and add either bus lane exclusive freeway ramps or a rail transit guideway that would, in the future, link the Metro Orange Line, the Metro Westside Subway Extension, the Exposition Light Rail Project and the Metro Green Line at Los Angeles International Airport. \$4,000,000
